

THE SANDRA CRONK MEMORIAL SCHOLARSHIP FUND

GUIDELINES AND APPLICATION

The Sandra Cronk Memorial Scholarship Fund awards scholarships to those accepted into its programs and to registered retreatants. Scholarships help lower tuition and registration fees for those demonstrating need.

For program participants: If at all possible the program participant should submit a scholarship application within two weeks of acceptance into a program. Applications will not be considered prior to acceptance; however, applications may be submitted at any time while the participant is enrolled in a program. A participant may submit more than one scholarship application if personal circumstances change during the course of a program. Acceptance into a program is not dependent on your ability to pay for the program.

For registering retreatants: If you are registering for a retreat, your scholarship application should accompany your registration.

The scholarship applicant should be aware of the following guidelines applied by the scholarship committee:

1. Strong preference is given to applications which demonstrate that financial support has been sought first from other sources, in particular from your monthly and yearly meetings.* (Additional documentation may be attached to support your grant application.)
2. It is expected that an applicant will make some personal contribution to the cost of the tuition or registration.
3. Scholarships awarded to any one program participant will not normally exceed 75% of the program tuition or retreat registration.
4. Normally, for any one program, the total scholarships awarded will not exceed 10% of the total tuition.


